COURSE OVERVIEW

Research at IIED Consulting has shown that agriculture makes up approximately 65% of Africa's labor force and 35% of the continent's GDP. These are driven up by factors like poor transportation and a lack of access to information and expertise – the primary reasons why so many struggle to escape from subsistence farming. Agriculture commodities exchanges, even done at micro-levels and integrated with the emerging ICT helps commodity exchanges integrate smallholder farmers into supply chains, reduce transaction costs, as it is easier to find buyers and sellers through a cent aliased marketplace. Consequently, agricultural commodity exchanges have the potential to facilitate trade and stimulate economic growth in Africa, potentially boosting foreign direct investment.
