### **Agri export values**

- Over 50% of SA's agricultural production is exported, in value terms. Fruit sector % is as high as 80% in some commodities.
- Total agricultural exports reached a new record of US\$13,2 billion in 2023, in spite of logistic, energy and input cost issues
- Very diversified trade, spread across multiple regions.
- Agricultural exports of US\$4,12 billion in the third quarter, 2024 a 5% increase relative to same period 2023. Total exports of US\$10,55 billion in 2024 to date up 4% from 2023 period.
- Year-to-date cumulative trade surplus up 3%, at US\$5,03 billion

# Agri export value

- Nationally citrus/grapes/apples/pears as a group = slightly higher export value than either SA manganese or chrome exports
  - Total SA agri exports are nearly 2 x iron ore export value
  - 4 x chrome, 3 x manganese
  - Nearly 2 x SA's iron & steel export value
  - 2 x SA's machinery export value
  - Close to vehicle export value

# Sanitary and Phytosanitary Access expected in near term (note, no tariff reductions)

- India: Citrus
- Thailand: Pears
- Philippines: table grapes
- China: Protocol awaited for pet food.
  - Still targeting pork, dried abalone, alignment of citrus SPS & shipping timeline, concurrent processing of application for blueberries, mangoes and cherries

# **Trade Policy Update – Africa**



### AfCFTA

- SA joined **Guided Trade Initiative** in January 2024. All non-sensitive (Category A) goods are included. 38 countries. 12 fully compliant. Trade may commence in these products.
- Protocols in Digital Trade and Competition now being negotiated, as well as goods Categories B (Sensitive) and C (Excluded).
- SA National Implementation Committee being formed.

# AfCFTA, continued...

### **Tools for trade under the AfCFTA**

• Searchable e-tariff book now live



- Africa Trade Gateway effort to digitise transactions for intra-African trade. Platform of platforms. eCommerce, due diligence, market intelligence, supply chain finance, payments. Financing, investment. Pan-African Payment system
- Plans underway to develop a **portal for SPS and TBT notification** as well as information sharing.
- Matchmaking possible via National/Country Focal Points
- Companies can register on AfCFTA database and receive AfCFTA token/ trader number

# Africa – TFTA, SADC, SACU



#### TFTA

• 14<sup>th</sup> country has ratified, now in force, trade expected early 2025.

#### SADC

Angola is acceding to the SADC Protocol on Trade. Offers have exchanged.

#### SACU

- Border closures, bans. Namibia and Botswana. Fresh produce and citrus. New Botswana government. Agbiz advocacy and engagement.
- Legality of border measures?
- Possible way forward, SACU channels, revive Sectoral Liaison Committees, Ad Hoc Tribunal, G2G engagement, B2B engagement. SACU study into non-tariff barriers underway.
- SACU study into utilisation of existing agreements & potential new trade agreements

### Trade Policy Update – EU / India

### EU

 Review of the SADC-EU Economic Partnership Agreement – impasse on scope of review. EU opposition to comprehensive review including market access revisions. The list of agricultural Tariff Rate Quota products may not be revised.

#### India

• SACU-India PTA – India seeking an FTA, not just a PTA. Uncertain.

### **Trade Policy Update - AGOA**

- SA citrus and avos SPS protocols remain in limbo. Apparent pork linkages for citrus.
- 2025 AGOA Annual review underway, outcome January 2025
- AGOA Renewal expected in 2025
- SA eligibility risks have lessened but remain. NDAA amendment, BRICS friction, Israel-Hamas war, out of cycle reviews.
- AGOA may be expanded, strengthened, or may be renewed largest in current form, but include trade in critical minerals

### **Trade Policy Update – BRICS**

- BRICS+ now comprises about half of global agricultural trade.
- However, intra-BRICS trade remains low.
- New members 2024: Egypt, Ethiopia, UAE, Iran
- 'Partner countries' 2024: Algeria, Belarus, Bolivia, Cuba, Indonesia, Kazakhstan, Malaysia, Nigeria, Thailand, Türkiye, Uganda, Uzbekistan, Vietnam
- Agbiz Chief Economist chairs Agribusiness WG
- Agribusiness position advanced a Kazan Summit via BRICS Business Council
  - Brazil, China, and South Africa most vocal about the need for tariff reduction
  - Agreed that BRICS+ must address any phytosanitary barriers that currently hinder trade.
  - WG members concerned with EU's environmental policies in agriculture

# Trade Policy Update – WTO

### WTO

### **SA-EU Citrus cases**

- False Coddling Moth (FCM) Stage 2 (Adjudication Panel) has commenced
- Citrus Black Spot (CBS) Stage 2 (Adjudication Panel) has commenced
- Stage 1 60 days, Stage 2 Panel 6 months. 18 months if appeal. Ruling: change measures or pay 'compensation (proportional tariff countermeasures to essentially match damage suffered). If EU refuses, SA can request permission to apply unilateral retaliatory countermeasures.
- The work of the Panel is expected to commence in early 2025 once both panels constituted and capacitated and initial research undertaken.
