#### E-CERTIFICATION BEST PRACTICE STAKEHOLDER WORKSHOP

Stakeholders in the fruit and agricultural export supply chain in and around Cape Town attended an e-Certification best practice workshop. The purpose of the workshop was to inform these stakeholders of DAFF's initiative to introduce paperless alternative electronic certification, and for participants to observe the current models being considered by the development team.

The expected outcome is that these stakeholders leave understanding the process DAFF is following to introduce electronic certification, will know where they can get involved in the process and what timelines for implementation are being targeted.

During the time between the second and third workshop, DAFF will be embarking on a pilot phase for electronic certification. A feedback session on the pilot phase is planned for the third stakeholders' workshop, provisionally scheduled for mid-October.
