#### **MARKET ACCESS: PHILIPPINES**

A FruitSA delegation is currently in Manila for discussions/meetings about access for South African fruit to the Philippines. The FPEF CEO is also doing a presentation on the SA fresh produce industry at a seminar which is part of the Agri-Link Trade Show and Conference. The delegation will also meet with the Philippines Southern Africa Business Council. This is the fourth year in which we participate in this trade show and meet with the relevant officials together with the SA Embassy (where Ambassador Martin Slabber and the Agricultural Attaché responsible for the Philippines, Mr Sithembele Kelembe) reactively support our market access efforts. It is hoped that the process with regards to citrus will be concluded in the not too distant future.
