#### **FRESH PRODUCE: INDIA**

A FruitSA delegation will participate next week in the *Fresh Produce: India* trade show in Mumbai (India). FruitSA is again a Gold Sponsor – which will add to a high visibility of our industry. The opportunity will also be used to engage with Indian government officials on market access issues.

### **VEGETABLE INDUSTRY VALUE CHAIN ROUND TABLE (VIVCRT)**

Seeing that we are the Fresh <u>Produce</u> Exporters' Forum, we are part of the recently established **Vegetable Industry Value Chain Round Table (VIVCRT)**. The strategic intent of the VIVCRT is to be a united voice for the common interest of the South African vegetable industry, in order to promote and grow this subsector to the benefit of all stakeholders. Initially, two working groups are established, namely a <u>Local and International Trade Working Group</u> and a <u>Transformation Working Group</u>. FPEF is primarily involved in the <u>Local and International Trade Working Group</u>, as well as in the bigger VIVCRT - which meets this week.

#### INDONESIA:

Cold treatment protocol amendments were made by PPECB for exports to Indonesia. This allows for exporters to reduce the risk of chilling injury on fruit (particular to citrus) while complying to the existing Indonesian import requirements. These amendments will generally improve fruit quality and assist exporters in the export process. Please find below extract from the PPECB cold treatment yellow card – please export accordingly and contact PPECB if you are still uncertain about the requirements:

### **SPAIN PORT VISITS**

The CGA and FPEF embarked on a project for normalizing trade for citrus fruit, directly to Spanish ports. Subsequent communication and meetings since October 2018 guided industry to potentially launch a pilot project for 2019.

Three ports were identified: Vigo, Algeciras and Barcelona/Tarragona and all of them reacted positively on the visit and conditions presented to them. We requested that SA should be subjected to the same conditions as any other 3<sup>rd</sup> country upon entry to the EU (particularly to citrus) through its ports. The conditions presented were (among other things): standard sampling as per current EU emergency measures & legislation and finalization of the official phytosanitary reporting procedure to DAFF with a copy to the CGA/FPEF in three working days of arrival etc. No special conditions should exist, and trade should continue as stipulated by the EU legislation.

At all three ports, parties agreed on the conditions that provide industry sufficient assurances to manage the risk. It is therefore up to industry to decide which port is most suitable to launch a pilot project in 2019, if any. A complete report on the findings of the visit will be available in due course. The CGA and FPEF will jointly host a meeting to present the findings and ultimately for industry to decide on a suitable port to enter directly into Spain.
